1. Quotations are required from freight forwarders with breakdown of charges for 40 feet high cube container (containing equipment and stores) as follows:-

- (a) Inland transportation from AMF, PAC Kamra to Seaport Karachi
- (b) Sea freight from Karachi Seaport to Doha, Qatar
- (c) Inland transportation from Doha Qatar seaport to Armed Forces, Al-Udaid Air Base.
- (d) Customer clearance Karachi Seaport to AMF (one way)
- (e) Customs clearance Doha Qatar Seaport (one way)
- (f) Port Handling Doha Qatar Seaport (one way)
- (g) Contractor must be the appointed freight forwarder of Pakistan region. Contractor must produce evidence of the same.
- (h) The store should be insured by an insurance company authorised to transact business in Qatar. A certificate should be rendered in this regard.

## 2. Delivery of Tender

- (a) **Technical Offer:** It should be without price and contain all relevant essential specification along with literatures / brochures. Tender number, date of opening and word “**Technical offer**” should be clearly marked on the face of envelope.
- (b) **Commercial Offer:** It should indicate price of quoted services and confirmation to the terms and conditions of our tender inquiry. The words “**Commercial offer**” be marked on its envelope. **Prices should be firm and final; there should be no hidden charges in the quotation.**
- (c) **Bid Money / Earnest Money:** The registered / unregistered firm with PAC Board will provide 5% earnest money of the quoted value through bank draft in favor of MD AMF PAC Kamra.
