- (c) Tender will be opened on **17 February**, **2025** at **1100** Hrs in the presence of available suppliers. We reserve the right to cancel or rejected all bids / proposals at any time prior to acceptance as per PPRA rules.
- 7. Validity of Offer: The quotation should be valid upto 30th June, 2025. Offer with less validity will be rejected.
- **8. Delivery Period:** Stores are required **within 04 to 12 Weeks.** Offer with minimum delivery period are likely to be preferred. However, the delivery period should be factual as no extension will be subsequently granted.
- **9.** Country of Manufacture: Country / place of manufacture of stores are to be provided along with Technical / Commercial offers.
- **10.** Release of Payment: Payment will be released by CMA ISOs Rawalpindi on submission of proper bill / sales Tax invoice, copies of GST registration / Professional Tax certificates, Sales Tax Return of current financial year and copy of relevant SRO.
